

80/20 AGREEMENT FOR SALE ON CONSIGNMENT

This is a consignment Agreement between _____
[*name of artisan*], a corporation/partnership/proprietorship [select one] duly organized and existing under the laws of the State of Texas, and having a principal place of business at _____, Texas _____, referred to in this Agreement as “Principal,” and BELOVED UNVEILED, LLC a corporation duly organized and existing under the laws of the State of Texas, with a principal place of business at 19321 Kennemer Dr, Pflugerville, TX 78660, referred to in this agreement as “Factor.”

Principal is engaged in the manufacture and sale of _____ [specify nature of goods sold], and Factor is engaged in the distribution of such products through Beloved Unveiled, LLC’s ecommerce website. By this Agreement, Principal engages the services of Factor in the distribution of these goods in the territory specified in the Agreement.

In consideration of the mutual covenants and agreements contained in this contract, the parties agree as follows:

1. Principal appoints Factor as an agent for the distribution of products presently manufactured by Principal and any other products that may be manufactured or sold by it after the date of this Agreement through _____, in an amount and at the prices specified in this agreement, and Factor accepts the appointment and agrees to act as agent under the terms and conditions specified in this Agreement.
2. This Agreement shall continue for a period of _____ year(s) from this date, unless sooner terminated as provided in this Agreement, or until _____ [Date].
3. Principal shall consign to Factor _____ [either those goods and products manufactured by Principal, as designated or selected by Factor, up to the amounts specified in a schedule incorporated in this Agreement as Exhibit A or the goods or products manufactured by Principal, as determined by Principal or otherwise specify amounts of goods to be consigned to factor].
4. The absolute title to all of the goods or products consigned to Factor by Principal shall remain in Principal until the goods or products have been delivered or shipped to a purchaser or purchasers obtained by Factor.
5. Factor shall at all times during the continuance of this contract use his/her best efforts to sell the goods or products to the retail trade via ecommerce site for Beloved Unveiled, LLC. Factor shall maintain a place of business in Texas, currently located in Pflugerville.
6. All shipping charges will be paid by purchaser which will be detailed on Beloved Unveiled, LLC’s website.

7. As compensation for the services to be rendered by Factor under this Agreement, Principal shall pay Factor:

A commission of twenty percent (20%) of the retail price of the goods sold by Factor for Principal, payable on the 15th day of each month for all goods sold in the preceding calendar month, and will be withheld from amounts remitted to Principal.

8. Principal reserves the right to add to, or change, its products under this Agreement by giving Factor notice in writing setting forth the name and purpose of the additional goods or products, the retail price, and other information required by Factor to handle such goods.

9. Factor shall on the 15th day of each month for all goods sold in the preceding calendar month, during the continuance of this Agreement, furnish to Principal a written statement showing (a) all products of Principal received during the preceding calendar month, and (b) all purchasers of the goods or products of Principal during that period, with the quantities purchased by each purchase and the retail price charged for the goods.
